

WITHDRAWAL POLICY

Valentis Markets

Valentis Markets is a Company licensed as Investment Dealer by the Financial Services Commission of Mauritius, under license number GB21026812 (hereinafter referenced as the “Company”). Ifexcapital and Luxren Capital are the brand names operated by the Company.

This Withdrawal Policy (the “Policy”) sets out our withdrawal policy for our clients. We have established the policies and procedures below to help ensure that all your withdrawal requests are processed efficiently and within the regulatory guidelines

Please note that withdrawal requests can only be submitted online via the official “Client Area” on our Website.

You must provide and/or confirm the following before submitting a request:

1. The Full name (including first and last name) on the beneficiary account which must match the name on the trading account;
2. that the withdrawal amount is less than or equal to the account balance;
3. In case a client has open positions, the below parameters should be fulfilled:
 - The free Margin level shall be more than 100% in order to submit the withdrawal request.
 - Prior and until the withdrawal request is approved and completed, the margin level should always be above 100%
 - There are no hedged positions on the account at the time of the withdrawal request.
4. The full details about the method used to deposit the funds, including the credit card or bank account number;
5. The full details about the method for withdrawal. Please note that our policy is to refund any funds back to the source of the original deposit. There is a minimum withdrawal amount of 50 (fifty) USD (or the equivalent currency). In case of profit, kindly note the minimum withdrawal requirement shall still apply.

Welcome Bonus and Trading Award Policy

The Company may offer attractive rewards to its new and existing Customers. Bonuses and/or financial awards or promotions (“Awards”) rewarded to Customers are part of the Company’s promotions program. These Awards have limited time offers. Prior to accepting any Award offer, Customers will be given the opportunity to consider the terms and conditions associated with the Award and these are subject to change.

In such case, where a Customer of the Company has received an Award, the terms and conditions in regards to the specific Award must be fulfilled prior to any withdrawal.

Processing Time Frames:

In order for us to perform our obligations and have time to process the payment with the credit card company or bank, the below shall apply:

All withdrawals requests shall be processed as soon as we receive your request and within a reasonable timeframe.

Before processing the withdrawal request, we reserve the right to review the trading account, account history and supporting documentation. We also have the right to request additional information prior to completing the withdrawal request. If necessary, we will contact you for further information. If we need to do this, we will cancel the withdrawal request until the outstanding matters are resolved. You will then need to re-submit your withdrawal request.

Please note that possible delays may occur relating to the Company’s third-party service providers.

Withdrawal of Profits:

Due to anti-money laundering requirements (AML) we must comply with, we need to verify that proceeds from trading are transferred to an account where the beneficial owner is the same as on the trading account. Therefore, it is recommended that you provide us with a copy of the bank or credit card statement where funds will be sent before you submit the withdrawal request.

Withdrawals will only be affected by the client. We will not affect withdrawals to any other third party or anonymous account.

Receipt of funds:

Banks and credit companies may have different internal procedures to credit funds that they receive. You acknowledge that we do not have control over when funds will be available. If you require a transaction confirmation, please contact the Support Department on support@ifexcapital.com or support@luxrencapital.com.

Initial Deposits Processed by Debit/Credit Card:

If you deposit your funds using a credit card, we will refund all amounts up to the amount deposited through that same card.

If you made a profit on your investments, we will return these profits via wire transfer. In some cases, the credit card company sets time limits for issuing refunds. If this timeframe expires, we will also return your funds via wire transfer. If this applies to you, please refer to the section above regarding processing.

In case the Company will not be able to refund the requested withdrawal amount to your credit card (or any other original source different than the one of a wire transfer) then it will be processed through Wire transfer and the minimum Wire Transfer requirements will apply (please refer to the section 'Withdrawal fee').

Our withdrawal process is based on strict guidelines to make sure your funds are securely sent back to their original source and beneficiary.

Withdrawal Fee:

In the case where the client requests a wire transfer withdrawal amounting to less than 50 (Fifty) USD (or the equivalent currency), the Company will have the right to apply the withdrawal processing fee of 30 (Thirty) USD (or the equivalent currency) which represents the bank charges.

The withdrawal processing fee shall be charged prior to processing of the wire transfer. In case if the request amount will be 30 (Thirty) USD (or the equivalent currency) or less the withdrawal request will be rejected.

Please take note that some banks use intermediary banks that charge fees. This will be your responsibility to find out about and settle.

Amendments and Complaints:

We have the right to review and/or amend this Policy and its arrangements whenever we find it necessary. We can do this with or without giving you prior notice. However, upon the event that the amendment limits your rights, we will notify you accordingly.
